

THE GODIVA VALENTINE'S DAY INSTANT WIN GAME
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST EIGHTEEN (18) YEARS OLD AT THE TIME OF ENTRY.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Godiva Valentine's Day Instant Win Game ("Promotion") is sponsored by Godiva Chocolatier, Inc. ("Sponsor"), 333 West 34th Street, New York, NY 10001 and is administered by Prize Logic, LLC, ("Administrator"), Two Towne Square, Suite 200, Southfield, MI 48076.

- 1. PROMOTION PERIOD:** The Promotion begins on December 20, 2022 at 12:00 PM (noon) Eastern Time ("ET") and ends on February 15, 2023 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion's official clock.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Officers, directors and employees of Sponsor, Administrator, Colangelo, Merkle, Tracy Locke, Lippie Taylor, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (all such individuals and entities collectively referred to herein as the "Promotion Entities") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. By entering the Promotion, entrant agrees that Sponsor can send entrant's information to LeVian for prize fulfillment purposes.

For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address on entry materials for purposes of this Promotion. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, all of that entrant's Game Plays (as defined below) associated with that household (determined by Sponsor and/or Administrator in its sole discretion) may be disqualified and any prize an entrant might have been entitled to win will not be awarded and may be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any entrant attempting such use.

- 3. HOW TO PARTICIPATE:** To participate, eligible entrants must obtain either a "Receipt" or "Code" as outlined below:

A. Make a Purchase to Obtain A Receipt: During the Promotion Period, an eligible entrant may purchase any Godiva product in store or online at a participating retailer (each a “Qualifying Purchase”), while supplies last. Entrant will receive a Receipt for each Qualifying Purchase and must save his/her Qualifying Purchase Receipt to submit as described below. **A Qualifying Purchase Receipt must be dated during the Promotion Period and include identification of retailer and Godiva product purchased to be valid. Any Qualifying Purchase Receipt dated outside of the Promotion Period or not identifying the retailer and Godiva product purchased will be voided and not eligible to win a prize.**

B. Without a Purchase to Obtain A Code:

i. Mail-in Promo Code Request: To obtain a Code without making a purchase from December 6, 2022 through February 1, 2023, an entrant may legibly hand write his/her full name (no initials), complete street address (no P.O. Box), age, and valid e-mail address on a 3½” x 5” properly stamped postcard and mail it to: The Godiva Valentine’s Day Instant Win Game Code Request, P.O. Box 251328, West Bloomfield, MI 48325. Requests sent in an envelope will not be accepted. Mail-in requests must be postmarked by no later than February 1, 2023 and received by no later than February 11, 2023. Administrator will send one (1) Code per Mail-In Request by e-mail to the e-mail address provided on the request. There is a limit of one (1) Mail-in Request per day per person/email address during the Promotion Period. Multiple mail-in requests by the same person/email address with the same postmark date will be deemed one (1) request. Mail-in requests will not be returned and no further correspondence will be entered into. Mail-in requests must be original and hand-written. No mechanical reproductions are allowed.

ii. Online Promo Code Request: To obtain a Code without making a purchase from 12:00 AM ET on February 2, 2023 to 11:59:59 PM ET on February 15, 2023, an entrant may visit <https://godivainstantwin.com/amoe> and follow the links and instructions to complete and submit the registration form including, but not limited to: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, and zip code. Upon the successful submission of the registration information, an entrant will receive one (1) unique Code via e-mail. An entrant may request a Code via this method one (1) time per day from February 2, 2023 through February 15, 2023.

All Codes and Receipts must be obtained during the Promotion Period.

During the Promotion Period, after an entrant has obtained a Code or Receipt, he/she must visit GodivaInstantWin.com (“Website”) and enter his/her e-mail address. An entrant must then follow the on-screen instructions to register by providing the information requested by Sponsor including, but not limited to, complete first and last name, street address (P.O. Boxes are not permitted), city, state, ZIP code, phone number, date of birth, and confirmation that entrant has read and agrees to be bound by these Official Rules. After completing the registration form, an entrant may submit the form to continue to either enter a Code or upload a Receipt. To upload a Receipt, entrant must follow the instructions to upload a photograph of the original register receipt showing the Qualifying Purchase. Each entrant must circle the

Qualifying Purchase item on the original Receipt. The file must be in .JPEG, .JPG, .GIF, or .PNG format and may not exceed 10 MB. No PDFs will be accepted. Each Receipt may only be used one (1) time.

After submitting a valid Code or uploading a valid Receipt, entrant will receive one (1) game play (“Game Play”). After the Game Play, the entrant will receive notification on the Website screen as to whether he/she is a potential “Instant Winner” (“Notification”). Potential Instant Winners will also receive an email notification from Administrator to the email address submitted on his/her registration form. Each entrant who receives a winning Notification will be deemed a potential Instant Winner subject to verification of the entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor in its sole discretion. An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant’s eligibility and the potential winning Game Play have been verified and entrant has been notified by Administrator that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any Game Play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored.

LIMIT: Regardless of the method used to obtain a Receipt or a Code, an entrant may only enter one (1) Code or Receipt per day during the Promotion Period. A “day” is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on each calendar day during the Promotion Period, except on December 26, 2022, when the day will start at 12:00 noon ET and end at 11:59:59 PM ET. In the event that a household enters the Promotion using more than five (5) unique e-mail addresses, all of the Game Plays associated with that household (determined by Sponsor or Administrator in their sole discretion) may be disqualified. If it is discovered or suspected, in Sponsor’s sole discretion, that an entrant plays or attempts to enter more than one (1) Code or Receipt per day, all of that entrant’s Game Plays, in Sponsor’s sole discretion, may be declared null and void and any prize(s) he/she might have been entitled to will not be awarded to him/her.

Prior to submitting the original register Receipt, it is strongly recommended that entrants print and maintain the original or a photocopy for themselves of all materials submitted. ENTRANTS SHOULD NOT SHOW OR GIVE A RECEIPT TO ANY STORE EMPLOYEE.

4. PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE (“ARV”):

A. Prizes (25): Each prize is a Godiva x Le Vian® Passion Ruby™ and Chocolate Diamond® heart necklace (each a “Prize”). No more than twenty-five (25) Prizes will be available in the Promotion. The ARV of each Prize is \$2,000.

B. Total ARV: The total ARV of all available Prizes in the Promotion is \$50,000.

C. Odds of Winning/Limit: The odds of winning a Prize depend on when the entrant completes a Game Play. Prizes will be made available at random times throughout the Promotion Period. To be a potential winner, an entrant’s Game Play must have occurred

either at the exact randomly predetermined winning time, as determined by Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play for that Prize to occur after that time will be deemed a winner. The number of Prizes available to be won will decrease during the Promotion Period as Prizes are awarded and claimed. There is a limit of one (1) Prize per person.

D. 5. HOW TO CLAIM A PRIZE: Each potential winner will receive an Instant Win Notification on screen and via e-mail from Administrator, after the completion of a winning Game Play. All entrants who receive a winning Notification are subject to verification of eligibility and compliance with these Official Rules. Each potential winner will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the Prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. If any potential winner is disqualified, determined to be ineligible or found not to be in compliance with these Official Rules, or, if any Prize is unclaimed, the Prize will be forfeited and, that Prize will not be awarded. If a Prize is forfeited, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining eligible non-winning Game Plays, as determined by Sponsor in its sole discretion. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded. Prizes will be mailed to verified winners at the physical address (PO Boxes not permitted) provided at the time of registration within approximately 4-6 weeks after verification. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for his/her Prize won. Sponsor will issue an IRS Form 1099-MISC for each winner. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not

received because of a winner's privacy or spam filter settings which may divert any Promotion e-mail, including any winner notification e-mail, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded.

The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website or any Promotion-related website(s). The Released Parties are not responsible for any injury or damage, whether personal or property, to participants or to any person's computer related to or resulting from participating in the Promotion and/or accepting or using a Prize. THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT**

PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS OR COLLECTIVE ACTION.
